Only those candidates, whose documents are found in order, shall be allowed to appear for Skill/Proficiency/Physical Test (SPPT) which shall be qualifying in nature only. It may be noted that only those candidates whose documents are found in order during Document Verification shall be allowed to appear for SPPT on the same day. However, only those candidates, who are found FIT by the Committee in SPPT, shall be considered for inclusion in Final Merit List based on their marks in the Computer Based Test (CBT). The detail of selection process for SPPT is already mentioned in our website notification dated 20-07-2024.

DATE, TIME & VENUE FOR DOCUMENT VERIFICATION

Call Letters for attending Document Verification have been sent to candidates on their registered e-mail IDs. Candidates are advised to check their registered e-mail for information regarding date, time & venue for Document Verification

DOCUMENTS REQUIRED FOR VERIFICATION

The following original documents along with self-attested copies are required to be furnished at the time of Document Verification:

- 10th Pass / Matriculation Certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- Caste (SC/ST/OBC)/EWS/Disability Certificate of reserved category candidates in the prescribed format issued by the Competent Authority.
- For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the format prescribed by Govt. of India, which would, among others specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt.(SCT) dated 08.09.1993 & OM No. 36033/1/2013-Estt.(Res.) dated 13.09.2017 and other guidelines issued from time to time. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Further, name of OBC caste mentioned in the certificate should fall in the central list of OBCs of the respective State and non-creamy layer status should be valid as on 20-07-2024.
- Semester-wise/year-wise mark sheets and Certificate of Full-time ITI/Diploma in Engineering in respective Discipline.
- Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma/ITI examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by the

University/Institute. The supporting document should also be produced at the time of SPPT in case the candidate gets shortlisted for SPPT.

- vi) Valid Discharge Certificate for Ex-Servicemen candidates.
- vii) No Objection Certificate, in case of candidates employed in Government/Semi Government/Public Sector Organization.
- viii) One Passport size colour Photograph.
- ix) **Persons with Benchmark Disabilities having only the disabilities of Leprosy Cured/Acid Attack Victims/Dwarfism with minimum 40% disability shall be considered as a PwBD candidate as per the Rights of Persons with Disabilities Act 2016, for the posts notified for them in Advertisement No.: PL/HR/ESTB/RECT-2024 dated 20-07-2024, and applicable relaxations/concessions shall be available to them.**
- x) Any other Certificate, if applicable.

IMPORTANT

1. **Without original documents, candidates shall not be allowed to appear for Document Verification.**
2. After verification, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself/herself shall be responsible for safe custody of original documents.
3. During document verification before the SPPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
4. The information furnished by the candidate in the online portal with regard to qualification, age, category, etc. shall be cross-checked from the original documents of the candidates.
5. Please note that during subsequent verification of documents, in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process without any further notice to you.
6. Please ensure that you fulfill all the eligibility criteria as stipulated in our detailed Advertisement No.: PL/HR/ESTB/RECT-2024 dated 20-07-2024, hoisted on our website www.iocl.com.

Candidates, who are pursuing higher qualification on the date of final submission of online application but have acquired/completed the same subsequently at the time of Skill/Proficiency/Physical Test (SPPT), shall not be eligible for selection and shall not be allowed to appear for SPPT. 


