



## Haryana Public Service Commission Bays No. 1-10, Block-B, Sector-4, Panchkula

### Corrigendum

The Commission vide advt. no. 14/2022 and 15/2022 published on 24.06.2022 with closing date as on 19.07.2022 had advertised 600 posts of Agriculture Development Officer (Administrative Cadre) and 100 posts of Agriculture Development Officer (Soil Conservation/Soil Survey). The essential qualifications for these posts were as under:-

#### 1. Posts of ADO (Administrative Cadre)

- (i) Degree in B.Sc. (Honours) in Agriculture from a recognized university.
- (ii) Sanskrit or Hindi upto Matriculation or 10+2, B.A/M.A with Hindi as one of the subject

#### 2. Posts of Agriculture Development Officer (Soil Conservation/Soil Survey)

- (i) Degree in B.Sc. (Honours) in Agriculture/B.Sc. Agriculture (Engineering) from a recognized university.
- (ii) Sanskrit or Hindi upto Matriculation or 10+2, B.A/M.A with Hindi as one of the subject.

Some candidates having degree in B.Sc. Agriculture filed various writ petitions in the Hon'ble High Court with a prayer to consider their candidature. The Hon'ble High Court vide its interim orders dated 15.07.2022 passed in CWP No. 14237 of 2022 Mohit Dhukia and ors. Vs. State of Haryana and ors. and other connected writ petitions have directed as under:-


*“Petitioners candidature be considered on provisional basis but they shall not be assessed in the written examination, and their answer-sheets shall be kept in sealed cover. It is expected of the respondents to accept the applications of the petitioners off-line, in case their online applications are not entertained on the ground of degree in question.”*

The Commission has considered the matter and in compliance of the above interim order, it has been decided that the petitioners in CWP Nos. 14237/2022, 14372/2022, 14579/2022, 14584/2022, 14862/2022, 15108/2022, 15143/2022,

15354/2022, 15539 of 2022, 15522 of 2022, 15654 of 2022, 15814 of 2022, 15894 of 2022, 15517 of 2022, 16000 of 2022, 16049 of 2022, 17211 of 2022, 16276 of 2022, 15721 of 2022 and CWP No. 16644 of 2022 are directed to apply offline in the format of application form which is available on the Commission's website i.e. <https://hpsc.gov.in>. The duly filled application forms alongwith copy of the orders of the Hon'ble Punjab & Haryana High Court will be accepted by the Commission latest upto 04:00 PM on 02.09.2022. Application fees shall be accepted through Bank Draft in favour of Secretary, Haryana Public Service Commission, payable at Panchkula. Other terms & conditions will remain unchanged. It is also made clear that only the application forms of petitioners of CWPs mentioned above and others CWPs in which interim relief has been granted by the Hon'ble High Court, for provisional consideration of the candidature, would be accepted by the Commission. The candidature of all such petitioners would be provisional and their answer sheets would be kept in sealed cover & will not be assessed, as directed by the Hon'ble High Court vide its order dated 15.07.2022. No further request/correspondence would be entertained after the closing date i.e. 02.09.2022.
