**Corrigendum to Advertisement No.4004/OSSC dated 07.10.2023**

**Subject: Corrigendum to the advertisement for Combined Graduate Level Recruitment Examination -2023 (CGLRE-2023) for recruitment of Group-B and Group-C state cadre posts/services in different offices under the Government of Odisha.**

Pursuant to the Commission's Advertisement No.4004/OSSC dated 07.10.2023 and Addendum Notice No.4243/OSSC dated 27.10.2023 following revisions are made.

**1. The following paragraph is inserted after Para- 4(a) Stage-III-Document Verification of the detailed advertisement:-**

"In case, during the stage of Certificate Verification, the Commission observes that the vacancy (ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in order of merit shall be called **only for one more time, at the discretion of the Commission** for filling up the number of vacancies not getting filled up".

**2. Para-3 (VI) of the detailed advertisement is replaced with the following clause:-**

"Based on performance in two papers of main written examinations candidates will be shortlisted for Certificate Verification."

**3. Number of vacancies position of CGLRE-2023 is revised to 576** Consequent upon addition of 02(two) more vacancies in Group-'C' Posts/Services as mentioned below:-

Accordingly, the total Sports Person reserved vacancies has been revised to 06(six) instead of 04(four).
