**Recruitment of Sub-Inspector in Delhi Police and CAPFs Examination, 2024:
Declaration of Revised Final Result**

The final result of Sub-Inspector in Delhi Police and CAPFs Examination, 2024 was declared by the Commission on 20.10.2025 recommending a total of 5296 (455 Female + 4841 Male) candidates. After the declaration of the result, large number of representations were received by the Commission. As the number of representation was unusually high, therefore, the Commission, in consultation with the nodal force i.e. BSF, immediately undertook a comprehensive review of the final result and found inconsistencies in the DV/DME/RME data provided by the nodal force i.e. BSF. Based on the said review, the discrepancies have been rectified. The Commission has now revised the final result of Sub-Inspector in Delhi Police and CAPFs Examination, 2024 recommending candidates over and above the vacancies reported so that no genuinely recommended candidate in the original result gets disqualified. The Commission has maintained the category wise / post wise cut-off marks of the last selected candidates of the original result declared on 20.10.2025. However, any slight change in cut-off marks of the last selected candidate is only to address the choices/ preferences of the candidates.

2. Based on the said review, the following changes have been effected in the result initially declared by the Commission on 20.10.2025:-

- i. 76 candidates who were not allocated in the original result but are allocated in the revised result. (List-1)
- ii. 12 candidates who were allocated in the original result but are not allocated in the revised result due to their not meeting eligibility conditions of the notice of the Examination. (List-2)
- iii. 178 candidates whose earlier allocation/ status has changed in the revised result. (List 3 containing 177 candidates excluding withheld candidate)

3. There is no change in the allocation of 5105 candidates in the revised result.

4. After completion of all stages of recruitment and based on the merit-cum- preference of post (s)/ force (s), candidates have been finally selected and allocated to the following posts:

- A - Sub-Inspector in Delhi Police
- B - Sub-Inspector in Border Security Force (BSF)

- C - Sub-Inspector in Central Industrial Security Force (CISF)
D - Sub-Inspector in Central Reserve Police Force (CRPF)
E - Sub-Inspector in Indo-Tibetan Border Police Force (ITBPF)
F - Sub-Inspector in Sashastra Seema Bal (SSB)
